FROM THE PRESIDENT

November

Coulda, woulda, shoulda. That's been my mantra for the last several months as our Pickleball Club's Board has made its way through the Capital Expansion Project. As I'm sure you all are aware, our club's board made the decision to withdraw the "Play Cool" Shade Project from consideration by the Community Association Board.

Are there things that we wish we had done differently as a board? Definitely. Did the Capital Expansion Committee work extremely hard to put together a good proposal? Without a doubt - they put forth a lot of time and effort on behalf of the club and our

members. Have we learned from this experience? I can only speak for myself; but I know that I've learned a lot about people and personalities and what we most likely should have done. This is the first time that a Capital Expansion Project was pursued by our club and I guarantee that we tried to do the best job that we could given the information we had at the time. Our intentions were always good.

Through this entire project our club board has tried very hard to be forthcoming and transparent. I realize that for many of you we didn't move fast enough, or that the decision that was made was not to your liking. But let me assure you that my goal, as well as those of the other seven board members, has always been to look out for the best interests of our club.

As part of our quest to be transparent, we have made sure that our monthly Board Workshop agendas and minutes are available to all club members on our club website. I know that many of you read them since I do get questions about some of the issues that are mentioned in those documents. But for those of you who have not had the chance to read them yet, I'm going to highlight a number of questions about court complex updates that we've received recently:

1) Court Resurfacing- The pickleball courts are on a six year resurfacing schedule. That means that the Retreat Courts are due to be resurfaced this year (they were built in 2018). However, I have met with the head of the CA Maintenance Department and also the Property & Grounds Committee to ask that they resurface Texas Drive Courts 1-4 instead (those courts were last resurfaced in 2019 and are due next year). The Texas Drive Courts are in much worse shape than the Retreat Courts. The CA budget was based on only four courts being resurfaced this year so I doubt that they will be able to do Courts 5 & 6. I believe the four Texas Drive courts will be resurfaced shortly; they are still waiting for a couple bids to come in. Resurfacing the courts will necessitate them being closed for a week. We will keep our members posted.

2) Ice Machines- The Community Association has told us that only Northpoint will have an ice machine by the courts. The only reason that Northpoint does have an ice machine is because there is not an amenity center close by. At Texas Drive and Retreat, members are encouraged to use the ice machines in the nearby amenity centers.

3) Lights on Courts 1-4- Back when the Texas Drive Courts were built, an agreement was made by then Pulte VP, Brent Baker, with the Community Association and neighborhoods near the Texas Drive Drive courts that no lights would ever be installed on Courts 1-4. That agreement has held up for many years. 22 out of the 26 courts are now lit and most nights there are plenty of courts open for evening play.

4) Court Dividers- The board is currently investigating and getting estimates for court dividers for all courts at both Retreat and Texas Drive. Since the cost would definitely exceed \$2500, club members would need to vote to approve an expenditure such as this. Stay tuned.

5) Backboard at Retreat- There are special windscreens (Acoustifence) that were installed at the Retreat Courts for noise abatement after complaints from neighbors in that area back when the courts were first built. At this point it would be difficult to install a backboard inside those courts without negating the benefits of the Acoustifence windscreens. A project like this could involve a lot of engineering to ensure that noise levels still are acceptable.

My one plea to each and every one of you who have read this far is to please remember our club motto - "Fun, Friends and Fitness." We have enough division in our world right now; pickleball should be FUN!

TREASURER'S REPORT

OCTOBER 2024 FINANCIALS

We began September 2024 with \$36,634.73 in our checking account. In the month of July, we revised the annual budget to add \$10,000 as a line item for our Capital Campaign. By dedicating this line item to the Capital Campaign for shaded courts, we can have net income for the year of more than \$2,500 without having to pay income tax. We had income in September of \$3,770.00 (\$300.00 new members, \$1,380.00 Fall Bash and \$2,090.00 capital campaign). After expenses of \$859.52 Professional services \$100.00, printing \$19.97, administration \$389.54, court activities \$18.80, Arlo cameras \$17,03, Court Reserve \$231.00, credit card fees \$8.51) and \$16.50 state sales tax, we ended September with a balance of \$39,528.71.

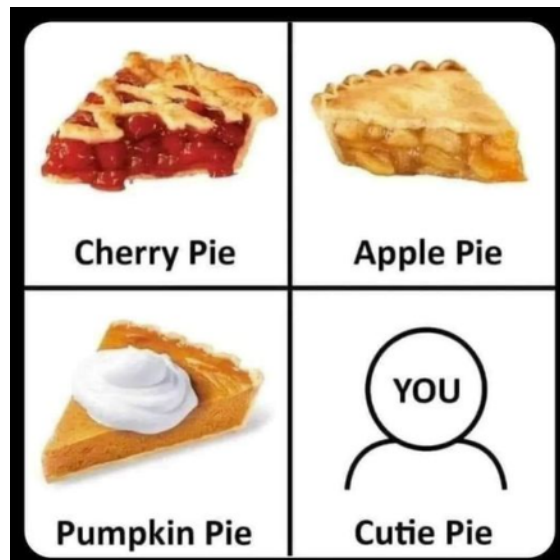

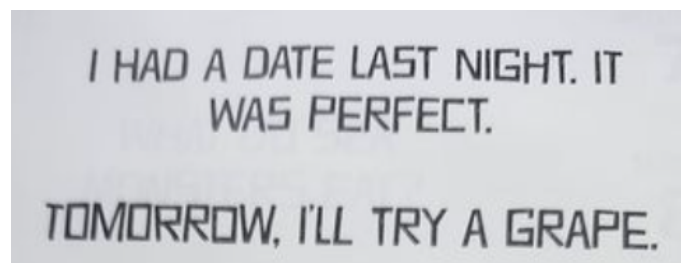
Train the Trainer

Richard is an International Pickleball Teaching Professional Association Certified (IPTPA), Level II Instructor and Sun City resident. He is an accomplished player and consistent medalist in the 4.0 division in both Men's and Mixed Doubles.

With 5 years teaching experience, his background includes pickleball teaching pro at the Rocky Hill Tennis and Fitness Center and East Hartford Tennis Club in Connecticut, volunteer with the Georgetown Recreation Department, instructor at the Georgetown Country Club, IPTPA Teach the Teachers workshop coach and Sun City Advanced Pickleball Strategy Lead Instructor.

A common theme in all of Richard's lessons and clinics is, "playing with a purpose," which means don't just hit the ball back, have a purpose for each shot. He believes that practice will develop the proper muscle memory, while playing with a purpose will improve your game. Beginners get a big dose of fundamentals and positive reinforcement, while his approach with more advanced players is to diagnose current tendencies, eliminate bad habits, fine tune shot selection and learn to move efficiently around the court to manage energy expenditure.

Just a Reminder, We've Changed Our Rates.

We have not had a rate adjustment for our teaching professionals in over 4 years. We will use this transition to adjust our Pro Teaching Rates. Note: they are still well below the current market rate that is charged outside Sun City (\$100 per hour or more for a private lesson). Effective September 1, 2024 the following rate schedule went into effect for all of our Teaching Professionals.

1 Hour Lesson per person - \$70 for 1; \$40 ea for 2, \$30 ea for 3, \$25 ea for 4.

90 Minute Lesson per person - \$100 for 1; \$60 ea for 2; \$40 ea for 3; \$35 ea for 4.

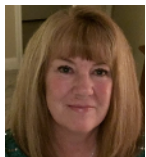
If you see trash, pick it up and dispose of it. If you see broken rubber tie wraps pick them up and dispose of them.
