

EXTERIOR PAINT POLICY

SERIES 100, 200, 300, 400 AND CUSTOM HOMES:

- Homes can be repainted the original colors with no paperwork.
- Homes can be painted a Developer color with approval.
- Homes must be painted with no less than three colors unless repainting the original one or two color scheme. - The committee will consider colors that are judged to be "close" to a Developer color.
- When requesting a "close" color, a color chip must be submitted and the Developer color must be designated.

COTTAGE HOMES:

- Homes can only be painted the original color.
- Homes must be painted in their entirety.

ALL HOMES:

- Project is to commence within 120 days of approval by the modifications committee.
- Project must be completed within 60 days of commencement

PAINT CATEGORY:

- STUCCO: Stucco and Garage Door
- TRIM: Thin wood around Windows and Garage Door, Fascia (Wood running horizontally and situated vertically under a roof edge), Pop-outs (Stucco feature that extends out from the stucco), Garage Door
- ACCENT: Front door, shutters and gable vents.

GENERAL PAINT SPECIFICATIONS:

- Semi-gloss paint is to be used on the Garage Door and the Front Door.
- Flat or low-sheen paint is to be used on the Stucco Walls.
- Flat or semi-gloss is to be used on remaining areas.
